

You have been given a summons to appear in the Platte City Municipal Court located at 900 Fourth Street (Southwest corner of Fourth Street & 92 Highway) in Platte City, Missouri. If you do appear before the Judge, certain types of clothing will not be considered acceptable, such as undergarments worn on the outside of clothing, shorts and hats. Please turn off cell phones and electronics.

SHOULD YOU FAIL TO APPEAR AT SCHEDULED COURT DATE, OTHER LEGAL PENALTIES AS PRESCRIBED BY LAW MAY BE IMPOSED FOR FAILURE TO APPEAR OR TO PAY AND DISPOSE OF THE VIOLATION.

If you wish to plead guilty, and do not want to appear in Court, you may satisfy those offenses listed below by:

Signing the back of your ticket and paying the fine at 355 Main Street, Platte City, MO (Police Department & Municipal Court Offices) Monday through Friday, 8:00 a.m. – 5:00 p.m.

Or

Signing the back of your ticket and mailing the ticket with a check, cashier's check or money order for the correct amount made payable to Platte City. Mail to Municipal Court, 355 Main Street, Platte City, Missouri 64079

(If you would like a receipt, please send a self-addressed stamped envelope.)

Excessive Speed Amounts:

1 to 10 miles over speed limit	\$78.00
11 to 15 miles over speed limit	\$128.00
16 to 19 miles over speed limit	\$178.00

Speed Amounts in excess of 19 MPH over the limit or in excess of 55 MPH requires a mandatory court appearance. (Over 55 MPH does not apply on I-29 highway where the posted speed limit is higher).

Compliance Citations

The following is a list of compliance citations:

1. All Equipment violations (Headlight/tail light, tint, etc.)
2. Failure to provide proof of insurance (insurance at time of stop must be provided)
3. Failure to produce a valid driver's license
4. Expired vehicle registration (Registration expired less than 60 days)

The listed citations may be dismissed if corrected prior to the listed court date and a certificate of compliance is completed. A certificate of compliance may be completed at the Platte City Police Department located at 355 Main Street, Platte City, MO 64079, Monday through Friday between the hours of 8:00am and 5:00pm except for holidays.
