To the fullest extent permitted by law, \_\_\_\_\_ agrees to indemnify, defend and hold harmless the City of Platte City, its officers, agents, volunteers, lessees, invitees, and employees from and against all suits, claims, damages, losses and expenses, including but not limited to attorneys' fees, court costs, or alternative dispute resolution costs arising out of, or related to the above use of City's facilities, buildings, equipment or infrastructure under this agreement involving an injury to a person or persons, whether bodily injury or other personal injury (including death), or involving an injury or damage to property (including loss of use or diminution of value), but only to the extent that such suits, claims, damages, losses or expenses are caused by negligence or other wrongdoing of lessee, its officers, agents and volunteers, or anyone directly or indirectly employed or hired by the lessee or anyone for whose acts the behalf of lessee may be liable, regardless of whether caused in part by the negligence or wrongdoing of City and any of its agents or employees.
2. No Provision of this agreement shall constitute a waiver of the City's right to assert a defense based on the doctrines of sovereign immunity, official immunity or any other immunity available under law.
