Primacy Fee to appear on August Bill :

Water Primacy Fee:

The water primacy fee, paid by the customers of Missouri's public water



supply systems, supports the Missouri Department of Natural Resource's (DNR) efforts to ensure Missourians are provided adequate water that is safe to drink. DNR uses the water primacy fee to fund testing for drinking water contaminants, inspections, compliance efforts, complaint investigations and technical program assistance.

Sewer Primacy Fee: The fee, known as the Missouri Water Pollution Permit Fee, is a state fee and will be forwarded to the DNR for use in its program to ensure that all publicly owned wastewater treatment facilities meet the requirements set by federal standards.
